How to process

Required Document:

1. A legible photocopy of water, electricity or telephone bill (within the last six months) bearing the residential address of the applicant;
2. 4 recent colour photos in size 1.5 inch;
3. A legible photocopy of the valid identity document(s) of every family member of the applicant who are under the same economic system;
4. A recent photo of every family member of the applicant who are under the same economic system.

Documents to be presented: Present the original valid Macao Resident Identity Card of the applicant.
