Targeted Food Surveillance

Objective: The Centre proactively identifies potential risks of the targeted food items and assesses the safety of food items commonly consumed in Macao in order to safeguard food safety.

Targeted Food Surveillance

The Centre conducts relevant analysis based on the types of foods.Priority will be given to the popular food items.



Surveillance on Pre-packaged Sweets

- There are a wide range of pre-packaged sweets in the market, including children's favorite fruit-flavoured soft candies, marshmallows, etc.
- Food additives such as sweeteners or preservatives may be added to enhance the texture or extend the shelf life of pre-packaged sweets.
- In order to collect information on the food safety situation of the pre-packaged sweets, Food Safety Center of IACM carried out a targeted food surveillance.

Popularity

Pre-packaged sweets in the market, including fruit-flavoured soft candies, sore throat lozenges, marshmallows and chewing gum, etc. Country or Region of Origin

China, Taiwan, Hong Kong, Malaysia, Japan, US, Germany, Swiss, etc.

Types of Samples

Collected a total of 40 samples of pre-packaged sweets, which include:

Test Parameters

Test Parameters- Sweetener

Sorbitol and sorbitol syrup, D-mannitol, Acesulfame potassium, Aspartame, Sodium cyclamate, Sodium saccharin, Stevioside, Neotame, Maltitol and Xylitol, in total of 10 tests.

■ Test Parameters- Preservative

Benzoic acid, Sorbic acid and Sulphur dioxide, in total of 3 tests.

Test Results

- All the samples were satisfactory. The overall satisfactory rate was 100%.
- IACM reminded the public to maintain a balanced diet. Avoid excessive consumption of pre-packaged sweet.
- In addition, phenylketonuria patients or people who are sensitive to sweeteners and other food additives should read the food label in detail when purchasing pre-packaged sweet. If necessary, consult your doctor before purchasing and consumption.

Advice To The Public

When purchasing pre-packaged sweets, you should:

- Purchase from approved and reliable sources;
- Check the packaging if it is intact and stored under appropriate condition, and pay attention to the expiry date;
- The products should be stored properly according to the label instructions. Consume as soon as possible after opening;
- It is difficult to verify whether the online food trading meets the food safety standards in various food processes, such as storage and transportation, the public should pay special attention to the nature of food and potential risks when purchasing food online.
- Do not purchase or eat any food if there is any doubt about its safety or quality, or the products have gone mouldy or melting;

Advice To The Trade

- The trade should purchase food products from reputable suppliers, meet the hygiene and safety requirements in various food processes such as transportation and storage, store and display the food properly;
- The trade should keep all the purchase and sales records for product tracing by the competent government authorities whenever necessary;
- Do not purchase or sell any food if there is any doubt about its safety or quality.





保存食品紀錄指引

目的

根據(食品安全法),食品生產經營者有義務在指定期間內保存進出賃紀錄5 相關單據·本指引百在使食品生產經營者了解保存食品紀錄的要件及如何妥會 進行相關的保存工作,以便一旦發生食品奉故時能讓政府權限部門進行及時表 效的食品溯源及跟進工作,共同攜手保障本演的食品安全。

補用節團

- 適用於所有擬供人食用的食品・根據(食品安全法)、「食品」指任何供人食用的經處理或未經處理的物質。包括飲料及香口膠類產品,以及在生養、配製及處理會品場際由於每期的於有的分。
- 本指引旨在為食品生產經營者提供原則性的保留食品紀錄建議,但受現行 其他指引規輸者,則可沿用既有的規定。

保存紀錄的內容:

為有效追查食品的來源和流向,保存紀錄的內容應清晰並涵蓋以下資料:

- 1. 食品的日期(獲取食品的日期;以批發方式供應食品的日期)
- 2 食品的來源資料(公司或個人的名程·助业及實話)
- 2 会员的數量
- 食品的描述(應為特徵性描述,讓人可清楚辨識,如食品名稱-批號及產 地來源等)。
