<p>預警發出之原因</p> <p>Motivo da Emissão de</p> <p>Alerta</p> <p>Reasons for Issuing Alert</p>	<p>根據香港食物安全中心發出的新聞公報，該中心接獲歐洲聯盟委員會食品和飼料快速預警系統（預警系統）的通報，指上述兩款意大利進口的飲品所使用的刺槐豆膠被驗出含有歐盟禁用的除害劑環氧乙烷。另外，該中心跟進早前公布法國進口穩定劑內使用的刺槐豆膠可能含有環氧乙烷，得悉一款多種口味的香港生產預先包裝雪糕曾使用受影響穩定劑。基於環氧乙烷已被歐盟禁用，上述受影響產品正進行回收。</p> <p>The Hong Kong Centre for Food Safety (CFS) announced that the CFS has received a notification from the Rapid Alert System for Food and Feed (RASFF) of the European Commission that the locust bean gum used in two kinds of beverages imported from Italy were found with a pesticide, ethylene oxide, which is not authorised by the EU. Furthermore, the CFS, upon following up on a stabiliser imported from France with the possible</p>

	<p>presence of ethylene oxide announced earlier on, was notified that the affected stabiliser has been used in a kind of Hong Kong produced prepackaged ice cream with various flavours. Since ethylene oxide is not authorised by the EU, the above-mentioned affected products are now being recalled.</p>
