

### Regulations for Members of IAM's Activity Centres (Fourth version)

#### Scope of applicability

- (1) Applicable to IAM's S. Lourenço Activity Centre, Rotunda de Carlos da Maia Activity Centre, Fai Chi Kei Activity Centre and Seac Pai Van Activity Centre.
- (2) Eligibility: Macao residents or non-Macao residents with legal residence in Macao.

### Method of application: Applicants are required to make their membership applications in person at any of the activity centres by submitting the following documents (free of charge).

- (1) For Macao residents, the following must be submitted:
  - 1. A completed membership application form;
  - 2. A photocopy of the applicant's valid Macao SAR Resident Identity Card;
  - 3. A 1.5-inch recent colour passport photograph;
  - 4. An applicant aged under 18 must submit a photocopy of the identification document of his/her parent or guardian together with the application form signed by the parent or guardian.
- (2) For non-Macao residents, the following must be submitted:
  - 1. A completed membership application form;
  - 2. A photocopy of the residence permit issued by the Macao SAR Government (with valid period not less than three months);
  - 3. A 1.5-inch recent colour passport photograph;
  - 4. An applicant aged under 18 must submit a photocopy of the identification document of his/her parent or guardian together with the application form signed by the parent or guardian.

#### Privileges / obligations / responsibilities of members

- (1) Upon completion of registration, the applicant can have immediate access to specified facilities of the activity centres. The applicant may redeem "Friends of IAM" card by presenting the temporary membership card after 20 days.
- (2) The facilities at the activity centres mentioned above are available to members free of charge.
- (3) Members are required to observe the rules for use of the activity centres, as well as the regulations for use of facilities. The centres' staff reserve the right to request a member to leave the venue if he/she interferes with the centres' operation.
- (4) A member with an accumulation of absence from queuing or reserved sessions five times within a period of 30 days will be suspended from using reservation service for 30 days.
- (5) Users of facilities at the activity centres are required to submit their membership cards which will be returned to them after use.
- (6) Activities or transactions related to monetary dealings, or promotions of a commercial nature at the centres are strictly prohibited.
- (7) Any member who causes damage to public property shall accept the related liabilities.
- (8) The membership card is non-transferable.
- (9) Any member who seriously interferes with the operation of the centres is subject to termination of membership.
- (10) IAM reserves the right to make amendments to these regulations in accordance with the actual needs without prior notice.



## Regulations for Members of IAM's Activity Centres (Fourth version)

### Loss /damage/renewal of membership card

- (1) For Macao residents, the following must be submitted:
  - 1. A completed membership application form;
  - 2. A photocopy of the applicant's valid Macao SAR Resident Identity Card;
  - 3. A 1.5-inch recent colour passport photograph;
  - 4. An applicant aged under 18 must submit a photocopy of the identification document of his/her parent or guardian together with the application form signed by the parent or guardian.
- (2) For non-Macao residents, the following must be submitted:
  - 1. A completed membership application form;
  - 2. A photocopy of the residence permit issued by the Macao SAR Government (with valid period not less than three months);
  - 3. A 1.5-inch recent colour passport photograph;
  - 4. An applicant aged under 18 must submit a photocopy of the identification document of his/her parent or guardian together with the application form signed by the parent or guardian.
- (3) Membership cards for Macao residents are valid for three years. The valid period of membership cards for non-Macao residents will be the same as that of the residence permit submitted by the applicant, but not longer than 3 years.
